- > The risk of injury from ammunition, shot, and arrows from firearms and archery equipment.
- Walking and driving in rugged country, including encounters with wildlife animals, insects, and reptiles (rattlesnakes).
- Inclement weather conditions.
- ➤ The risk of injury from riding live mules, horses, all-terrain vehicles or ANY vehicle used on **or** off a paved rd.
- ➤ The risk of injury from the use of tree stands, ground blinds, stick blinds etc.
